#### CONDITIONS OF SALE SALE BY TENDER

Due to Covid-19 the sale is being conducted on a written tender basis.

Written tenders are requested by email to be submitted to Carter Jonas to john.read@carterjonas.co.uk by 4pm on Thursday 21<sup>st</sup> January 2021.

Tenders are requested to the highest maximum bid on a 'per lot' basis. Once submitted the amount of tender may not be increased or decreased. As per our usual conditions of sale for Commission Bids Carter Jonas will take the highest tender being the next bid on so that lots are purchased as cheaply as possible as allowed by other tenders received. No VAT is payable.

#### 1. **BIDDING**

The highest bidder to be the purchaser. The Auctioneers reserve the right to refuse any tenders and, in the event of any dispute, the lot may be put up again at the Auctioneers' discretion.

#### 2. RESERVES

All lots are put up for sale subject to any reserve price imposed by the Vendor.

#### **3. DESCRIPTION**

The description of the various lots is believed to be correct. In the absence of a specific number of bales approximate numbers of bales in each lot are given in the catalogue, but it must be emphasised that this information is given for guidance only. No warranty as to weight, quality or condition can be given and an intending Purchaser must, without exception, inspect any lot in which he is interested, and raise any queries with the Auctioneers before the lot is sold.

#### 4. PAYMENTS

All lots are sold for cash and must be paid for on receipt of an invoice. Payment by BACS credit transfer is preferred. If paying by cheque, no lot can be removed until the cheque has been cleared (except with the written permission of the Auctioneers).

#### 5. METHOD OF SALE

All lots are baled and the majority sold "per lot" and prospective Purchasers must make their own estimate of the tonnage.

Where the catalogue states an exact number of bales to be sold this is guaranteed to the Purchaser (except when lost through fire, theft, accident, etc for which insurance cover must be maintained by the Purchaser – see below) The Purchaser must make his own arrangements with the Vendor to ensure that the numbers loaded are counted and agreed.

#### 6. REMOVAL

All lots must be removed before 25<sup>th</sup> March 2021 or any earlier date which is stated either in the catalogue or at the time of sale. If not so removed, the Purchaser shall pay a penalty of 10% of the sale price per week for each lot or part of a lot until final clearance. The Purchaser shall indemnify the Vendor against any damage that may be caused to gates, fences, buildings etc in the course of the removal of any lot. The labour for clearance of each lot (other than help with loading to the lorry) is the sole responsibility of the Purchaser. Rick sheets and covers remain the property of the Vendor.

#### 7. ORDER OF SALE

The Auctioneers intend to sell in the order lotted and as described in the catalogue but reserve the right to make any alternations if so requested by the Vendor.

#### 8. LIABILITY

Neither the Vendor nor the Auctioneers will be responsible for any lots lost or damaged by fire, theft, accident or otherwise from the fall of the hammer and all lots are the Purchaser's responsibility from the fall of the hammer.

#### 9. NON-COMPLIANCE WITH CONDITIONS

Upon failure to comply with any of the above Conditions, the Auctioneers may re-sell the lot or lots by public or private auction, without notice to the former Purchaser, and the deficiency (if any) by such second sale, together with all charges attending the same, shall be made good by the defaulter.

#### **10. SALE AFTER AUCTION**

The Auctioneers sell as Agents for the Vendor and, in the event of non-sale any future negotiations must be made through the Auctioneers as Agents for the Vendor. These conditions of sale will apply, subject to any written arrangements to the contrary.

#### **11. MOVEMENT RESTRICTIONS**

In the event of the farm becoming subject to movement restrictions due to contagious or other disease regulations the Vendor will be under no obligation to release the lots to the Purchaser until such restrictions are lifted. In these circumstances the Purchaser will be entitled to interest on his payment from the Vendor from the date of imposition of movement restrictions until the date of removal at Barclays Bank plc base rate.

#### **GENERAL NOTES**

#### **1. ADDITIONAL INFORMATION**

The Auctioneers will be pleased to supply additional information on any particular lot so far as they are able, as to quantity, quality, position and assistance with loading, where available.

#### 2. INSURANCE

Buyers are reminded that each lot is their responsibility from the fall of the hammer and that adequate insurance cover for all risks should be taken out at once.

#### **3. VIEWING**

Please carry this catalogue with you as evidence of your permission to view and make yourself known at the farmhouse on arrival. Some lots require viewing by arrangement due to locked gates etc and this is stated in the catalogue. DUE TO COVID-19 WE REQUEST THAT ALL BUYERS CONTACT VENDORS PRIOR TO VIEWING.

#### IMPORTANT NOTICE RE LOADING

Unless otherwise stated, Vendors will give assistance with loading (providing a telescopic loader with driver or one man) subject to:
