The first floor incorporates a guest bedroom with ensuite shower and wardrobes, a principal bedroom with an ensuite, 2 further double bedrooms and family bathroom.

Stairs rise to the 5th bedroom on the 3rd floor.

Surrounding gardens backing onto paddocks, driveway parking and garage. Paddock and stable available by separate negotiation.

Inkpen is a sought-after scattered village in West Berkshire, surrounded by particularly attractive and unspoilt countryside, with good opportunities for riding and walking. It is within 2 miles of Kintbury with its excellent local shops and main line railway station, whilst the market town of Hungerford is within 4.5 miles. Newbury with main line station (Paddington 40 minutes) is within 9 miles, whilst Junctions 13 and 14 of the M4 Motorway are within 11 and 8 miles respectively.


